Note-

1. A student eligible for scholarship has to submit all the documents in original.
2. % in 12<sup>th</sup> will be calculated as per the eligibility criteria specified in Admission Brochure of GGSIPU for the academic session 2022-23.
3. CUET score will be calculated as per the eligibility prescribed by GGSIPU.
4. SHTR sponsored scholarship may be availed in the first year of admission subject to fulfilment of eligibility and verification of documents.
5. For the subsequent 2nd and 3rd year, continuation of scholarship is subject to performance of the student and fulfilment of the following criteria: a) minimum 75% marks in aggregate of previous two semesters b) No back papers c) Minimum 85% Attendance d) No disciplinary action against the student.
6. A student may avail scholarship scheme through external schemes, or through internal schemes of the Institution, but not through both the options. If the student is eligible for external schemes, then first preference will be given to avail the same, and if there is some shortfall, then the balance amount may be utilised from the SHTR sponsored scholarship.
7. In case a scholarship student is found indulging in any act of indiscipline, the scholarship shall stand immediately withdrawn.
8. The decision of the scholarship committee shall be final and binding. The scholarship committee shall be constituted by the Director.
9. If CET is not held for any year, then it will not be a required criterionforaward of SHTR sponsored scholarships.
10. The scholarship can be availed only by those students who take admission in the Institution following the due admission process as notified.
11. Scholarship in the first year of admission will be a reimbursement of fee after the last date of withdrawal.
