Key Learnings	The Indian Council of Social Science Research (ICSSR) sponsored Twentieth Annual International Conference on the broad theme "Global Vision 2030: Challenges & Opportunities" held on January 4-5, 2019 was hosted by Deen Dayal Upadhyaya College, University of Delhi, Delhi; and Delhi School of Professional Studies and Research (an affiliated college of Guru Gobind Singh Indraprastha University, Delhi; & a NAAC Accredited 'A' Grade Institution), under the joint auspicious of Shyam Lal College (E), University of Delhi; Sri Aurobindo College (E), University of Delhi; Indian Commerce Association Delhi-NCR Chapter; Rotary Club of Delhi Maurya; and Divine International Group of Institutions, Gwalior.
	More than 250 academicians, researchers, students, and practicing managers both from India and abroad participated over the two-days spread, punctuated by inaugural and valedictory sessions. 94 papers were presented across the two days of the conference representing countries, namely, USA, South Africa, Oman, Bhutan, Nepal, and India.
	Apart from the broad theme, the Technical Sessions were categorized into following sub-themes: 1. Industry, Innovation, and Infrastructure 2. Artificial Intelligence: Vision 2030 3. Sustainable Energy Management

4. Crypto Currency: Future Perspectives

5. Research Paper Presentations on Contemporary Issues

The inaugural of the conference was ornamented with the presence of Rev. Dr. Swami Parthasarthy, Member of Joint Commission of BRICS Countries & India's Permanent Envoy to UNECOSOC - Chief Guest; Prof. Rajendra P. Srivastava, Ex EY Professor of Accounting and Information Systems, School of Business, The University of Kansas, Lawrence, Kansas, USA - Key Note Speaker; Prof. B.P. Singh, Chairman, Delhi School of Professional Studies and Research (DSPSR) - Chairperson; Dr. Namita Rajput, Principal (OSD), Sri Aurobindo College (E), University of Delhi; Prof. Reetesh Kumar Singh, Professor, Department of Commerce, Delhi School of Economics, University of Delhi, Delhi; Prof. R.K. Mittal, Vice- Chancellor, Chaudhary Bansi Lal University, Bhiwani, Haryana - Guest of Honours; Dr. Anil Kumar Singh, Associate Professor, Sri Aurobindo College (E), University of Delhi - delivered special address; Rtn. Prof. Ajay Kr. Singh, Secretary General, Organizing Committee - delivered theme address; Dr. H.C. Jain, Principal, Deen Dayal Upadhyaya College, University of Delhi, - delivered welcome address; and Prof. Ravinder Vinayek, Director, Delhi School of Professional Studies and Research extended vote of thanks.

The honored speakers touched upon the various aspects including the challenges and opportunities of the sustainable development goals. The discussion highlighted the key issues in the context of sustainable development like population, food security, urban challenge, energy, industry and environmental degradation. He explained that the basic barrier to the development of any country is poverty and hunger. It was emphasized that efforts should be made to deal with the issues related to sustainable development. Views were also exchanged over trade and green economy, social inclusion, low carbon transport and water to maintain the sustainable development at local, national and regional level.

Inaugural was followed by XX Annual International Seminar Session on 'Sustainable Development 2030: The Road Ahead'. The panelists included Shri Gauri Shankar Gupta, Former Ambassador/High Commissioner of India; Prof. Ravinder Rena, Professor of Economics, NWU School of Business, North West University- Mafikeng Campus, South Africa; Prof. Suneel Maheshwari, Professor, Indiana University of Pennsylvania, Pennsylvania, United States of America; Prof. Rajendra P. Srivastava, Professor Emeritus of Accounting & Information Systems in the School of Business, University of Kansas, Lawrence, USA; and Prof. L.S. Singh, Formerly Head, Department of Economics, Magadh University, Bodh-gaya.

The panel echoed the view over the threats we are facing in relation to Sustainable Goals 2030, and the immediate actions that we should be taking to combat the same. The major challenges that were enumerated included the population explosion, economic disparity, health challenges like the spread of HIV-AIDS, malaria, etc. and also availability of clean drinking water in the future. Also, there was discussion over views on the topic of effect of human encroachment of natural

resources by focusing over urbanization and human activities over putting undue pressure on the limited natural resources. In continuation to these, they also talked about promoting E-books and E-learning so that trees and our mother earth could be saved. There was also emphasis over the topic of rise of artificial intelligence and to make changes in education system in order to make the youth more hands on with the future scenario and the future challenges.

An industry session on "Corporate Expectations from Young Managers" was held on the 2nd day of the conference. The speakers included Rtn. Subhash Jagota, CEO, Global Solutions; Shri Beni Kinha, Founder, Nectar Factor, Delhi, India; Shri Abhay Kapoor, Head HR - North India, Amazon India; Shri Sanjiv Nanda, Director, SmartHead Consulting, New Delhi and Shri Arun Bhutani, Director.

The speaker opined about the importance of short term assignments. It was also discussed about how important the final performance of an employee is for the private sector company, and about the quality of born leader and situational leader. They explained with the example of Swami Vivekanand as a born leader, and also explained why Mahatma Gandhi as a situational leader. Emphasis was given over the discussion about the importance of change, ability to change, adapt the change, and adopt the change according to the situation demanded.

The Valedictory Session was addressed by Prof. H. Venkateshwarlu, Professor, Faculty of Commerce, Osmania University, was the Chief Guest of the session.
