STAKEHOLDERS' FEEDBACK ANALYSIS AND ACTION TAKEN REPORT FOR THE SESSION 2022-23

The importance of including stakeholders in the quality assurance of good education has become increasingly apparent as a result of the feedback analysis process. Stakeholders have an active role in their children's holistic development. The institution has been taken in account the feedback from stakeholders in terms of what they need for effective teaching and learning. The institution has a feedback process in place to receive useful curriculum feedback from students, parents, and employers in order to improve students' skills and employability. Every academic session, students are surveyed three times for feedback. After four weeks from the start of the session, in the middle of the semester, and at the end of each semester, in the form of an Online Feedback System based on some factors established in the feedback system. The IQAC department is in charge of circulation, distribution, and collection of completed feedback forms.

Objectives of Stakeholders' Feedback mechanism:

The Stakeholders' feedback has three main objectives:

- 1. To provide stakeholders the opportunity to comment on the quality of the students' learning experience, as required in preparation for and as part of review process.
- 2. To assess the success of academic provision in relation to the expectations of all the stakeholders
- 3. To provide feedback to the faculty members in order to improve delivery and/or content of the curriculum.
- 4. To bridge the gap between academia and industry.
- 5. Employer's input is utilized to improve the Knowledge, Skills and Ability of students so that they are better prepared to perform at their place of employment.

The stakeholders' feedback is collected in different modes like online feedback through Google forms, and written feedback. The collective feedback of all the stakeholders was analyzed and a consolidated report of the recommendations is prepared.

Analysis and Outcome:

- It has been observed after the analysis that most of the students of BBA 1st year were in agreement that the course was conceptually easy to understand. But the syllabus was challenging for Business Mathematics, Financial Accounting & Analysis. But the course of E-commerce and E-commerce lab was conceptually difficult to understand. The majority students agreed that they have been provided with a course and lecture outline at the beginning and every subject teacher encouraged student participation in the class.
- The results indicated that the students of BBA 2nd year were of the opinion that the prescribed reading of the course was easily available and library material was very useful. The student

found the syllabus of Management accounting and Financial Management were quite challenging and course was comparatively difficult to understand. The students agreed that the assignments were properly discussed in the class and the syllabus was thoroughly covered in the class.

- The analysis revealed that the BBA 3rd students were of the opinion that the syllabus was challenging for Goods & Services Tax. The students favored that the teachers encourage the student participation in the class and the prescribed reading for the course was easily available. The students favored that the Sales and Distribution Management, Service marketing was conceptually easy to understand. The students favored that the assignments were properly discussed in the class and course outline were provided in the beginning.
- The findings suggested that the students of B. Com (Hons.) 1st year found the syllabus of micro economics and Business Mathematics was quite challenging. The teacher encouraged the student participation in the class and the assignments were properly discussed in the class.

The students were highly satisfied with the prescribed reading material and library material.

- It has been observed from the analysis that the syllabus of B.com (Hons.) 2nd year subjects like Management Accounting, Corporate accounting, Financial Modelling, Financial Modelling Lab was quite challenging. The prescribed reading course was easily available for all the subjects. The students feel satisfied with the internal assessment criteria.
- The results suggested that the B.com (Hons.) 3rd year syllabus was quite challenging for the subjects like Income Tax Law and Practice, Investment Management. The students feel satisfied with the teacher's encouragement in the class for class participation.

FACULTY FEEDBACK ANALYSES AND ACTION TAKEN REPORT FOR THE SESSION 2022-23

Objectives of Faculty Feedback mechanism:

- 1. To make educational system more effective and more adaptable for students to achieve excellence.
- 2. To collect information relating to satisfaction of faculty members towards the curriculum, teaching, learning, and evaluation.
- 3. To ascertain the need for the revision of the course content.
- 4. To help in future development of the curriculum material for continuous improvement.
- 5. To improve methods of teaching and instructional techniques.

Analysis and Outcomes:

- 1. From the given graph analysis, about 15 faculty members strongly agreed that the practical enables development experimental, design, problem-solving, and analytical skills of the students, while 20 faculty members were also found to agree with this aspect. 12 faculty members were found to be neutral, 4 were in disagreement, and the other 2 were found to strongly disagree that the practical enables the development experimental, design, problem-solving, and analysis skills of the students.
- 2. 14 faculty members were found to be neutral towards stimulating the interest of students in the subject and deepening their understanding through relating theory to practice. The overall majority of the faculty members (11 agreed, 14 strongly agree) agreed that the designed experiments stimulated the interest of students in the subject and deepened their understanding by relating theory to practice.
- 3. The faculty members were found to stronglyagree that the allocation of the credits to the course is appropriate (23 agreed, and 10 strongly agreed).
- 4. Majority of the faculty members agreed that the units/sections in the syllabus are properly sequenced (10 agreed, and 20 strongly agreed).
- 5. 18 faculty members were found to be agreed and 15 to be towards the possibility of the timely coverage of syllabus in the mentioned number of hours
- 6. 8 faculty members strongly disagreed and 12 disagreed that there is sufficient freedom to adopt new techniques/strategies of testing and assessment of students in the curriculum.
- 7. The faculty members were found to be equally divided in terms of the contents of the curriculum as per the industry requirement.
- 8. Majority of the faculty members agreed that the books prescribed/listed as reference materials are relevant, updated, and appropriate (9 agreed, and 25 strongly agreed).
- 9. Majority of the faculty members disagreed that the course/program of studies carries a sufficient number of optional papers (20 disagreed and 8 strongly disagreed).
- 10. Faculty members were found to agree with the celerity in the syllabus, and increase their knowledge and perspective in the subject area after teaching the curriculum.





Analysis:

From the above graph and table it can be said that 77.14 % employers are agreed that the syllabus is adding Learning values (in terms of skills, concepts, knowledge, analytical abilities or broadening perspectives) in students, and 85.71 % confirmed that the syllabus is compatible with the industry standards & relevant to real life situations. 91.42% respondents rated highly for the sufficiency of the courses in relation to employability. And students are capable enough to solve the work place problems. 100% employers said that the current curriculum is sufficient to inculcate skills like working in a team, communication skills, enabling the students for developing practical solutions to work place problems, to relate theory to practice, and effective in developing skill oriented human resource. 85.71% companies rated that syllabus is sufficient to groom the students into the entrepreneurs.


