

- 1. A student eligible for scholarship has to submit all the documents in original.
- 2. SHTR sponsored scholarship may be availed in the first year of admission subject to fulfilment of eligibility and verification of documents
- 3. For the subsequent 2<sup>nd</sup> and 3<sup>rd</sup> year, continuation of scholarship is subject to performance of the student and fulfilment of the following criteria: a) minimum 75% marks in aggregate of previous two semesters b) No back papers c) Minimum 85% Attendance d) No disciplinary action against the student.
- 4. Tuition Fee here refers to the fee payable by the student to DSPSR after deducting GGSIPU's share and DHE's share out of the same.
- 5. A student may avail scholarship scheme through external schemes, or through internal schemes of the Institution, but not through both the options. If the student is eligible for external schemes, then first preference will be given to avail the same, and if there is some shortfall, then the balance amount may be utilised from the SHTR sponsored scholarship.
- 6. In case a scholarship student is found indulging in any act of indiscipline, the scholarship shall stand immediately withdrawn.
- 7. The decision of the scholarship committee shall be final and binding. The scholarship committee shall be constituted by the Director.
- 8. If CET is not held for any year, then it will not be a required criterion for award of SHTR sponsored scholarships.
- 9. The scholarship can be availed only by those students who take admission in DSPSR following the due admission process as notified.
- 10. Scholarship in the first year of admission will be a reimbursement of fee after the last date of withdrawal.
